FEATURED JOB



PSC Crane & Rigging was awarded two separate contracts relating to the installation of a new flight simulator system at the WPAFB Human Performance Wing. The first contract awarded was the transportation of two (2) large steel embeds from a fabricators facility in northeast Ohio to Fairborn, Ohio.

The 1st "Lower Embed" had a shipping weight and dimension of 18,000 lbs. x 18' in diameter & the 2nd "Upper Embed" had a shipping weight and dimension of 41,000 lbs. x 21'in diameter. The second contract awarded to PSC was to unload, rig inside the building structure and lower into a concrete shaft, which was 50' x 50' square at a depth of 45'. The use of our 165 Ton Grove AT Crane was utilized to unload both steel embeds from the trailers. Once unloaded, a pair of 40/60 Versa-Lifts with rigging booms were utilized to carry the steel embeds inside the building. Both steel embeds had to be suspended from the rigging booms on an angle due to the opening in the concrete barrier wall being smaller in width than the diameter of the steel embeds. Once inside the building structure, both steel embeds were lowered into final position inside the concrete shaft, precision aligned and leveled within 3 microns where they became an integral part of the main foundation required to house the new flight simulator.

The most difficult challenge of this project was lowering the "Lower Embed" into final position at a depth of 45'. PSC elected to use both 40/60 Versa-Lifts with special rigging boom attachments, cable winches & hook blocks to overcome the challenge. Another fine example of PSC's team of professionals, both office and field personnel, committed to innovative thinking, planning, engineering and execution to overcome a series of rigging and safety challenges associated with this project. The final outcome resulted in a smooth, efficient and flawless installation.

"Safety Bucks" Program

To keep safety in the minds of all of our employees, PSC has established a safety incentive program. This highly successful program is called the "Safety Bucks" program. After being employed for 250 work hours, each employee is eligible to earn \$25 for each 250 hours worked without injury, property damage, or customer complaint. Each time an employee earns this bonus; their name is entered in a year-end drawing for \$1,000. It is possible to earn every incentive and have up to 10 chances for the \$1,000. Safety awareness is critical to any successful program and PSC believes this incentive is vital in our efforts to be the safest company in our industry.
